**Harris**

- Introduced a [bill](#) to prohibit application of Religious Freedom Restoration Act.
- [Opposed religious exemptions](#) from contraceptive mandate.
- Supported [gender transitions](#) for children; supported men in women's sports.
- Wants to install [Chief Advocate for LGBTQ Affairs in White House](#).
- Voted against [Born-Alive Abortion Survivors Protection Act](#); Supported [codifying Roe v Wade](#); Supported VA health facilities providing abortion; Proudly visited Planned Parenthood
- Israel: Described Gaza situation as humanitarian catastrophe.
- Supports [Expanding Supreme Court](#).



**Trump**

- Executive Orders: Signed [Promoting Free Speech and Religious Liberty](#) to try and repeal the *Johnson Amendment*. [Created Religious Liberty Task Force](#)
- Healthcare Conscience: Protected [healthcare workers' rights](#) to opt out of procedures like abortions. Opposed gender transition surgeries for children.
- Judicial Appointments: Appointed conservative judges, including three Supreme Court justices, overturning *Roe v. Wade*.
- International Focus: Signed [Executive Order protecting international religious freedom](#).
- Israel: Recognizing Jerusalem as capital; moved U.S. Embassy; Abraham Accords; withdrew from Iran deal.
